Additional Information

Clients will be required to have Internet breakout in order to utilise the Cloud Backup services. An installation of the software client needs to be installed locally on all devices (laptops, desktops and servers) requiring backup. Adept does provide an option for assisted installation.

Supported operating systems include MS Windows, MacOS and various Linux distributions.

All users will have complete control over the data selected for backup and restoration, as well as for setting and maintaining backup schedules. Adept does not have access to client's data and therefore cannot guarantee data fidelity.

All standard packages are a month-to-month service, and data packages cannot be stacked as they are per-device packages. Custom solutions will be contract-based.
